# Southeastern Chapter - On the Move President's Report



It was a true honor to attend PVA's National Convention in Austin, Texas this year—my first time representing the Southeastern Chapter at this national gathering. I'm proud to share that the progress we've made in

strengthening the way our chapter conducts business was recognized multiple times by members of the National Executive Committee. In fact, we've been asked to collaborate with the leadership of two other chapters to share the strategies behind our improvements. It's encouraging to see our chapter becoming a model for others.

The Board of Directors has made the important decision to retain our current building and property. With the rising costs in the Medical District real estate market, it's not financially feasible to relocate at this time. Instead, we're focusing on maintaining and upgrading our current space. We're gathering estimates

for roof replacement and additional repairs to ensure our building continues to meet the needs of our members. As outlined in the Executive Director's report, we're actively pursuing grant funding to help cover these expenses.

In June, I'll be representing our chapter at the annual Legislation and Advocacy Seminar, followed by the Push on the Hill event in Washington, D.C., from June 10th–12th. There, I will meet with members of Congress from South Carolina to advocate for the healthcare, benefits, and accessibility needs of our veteran community and all individuals living with mobility disabilities. A full report on these efforts will appear in our August/September newsletter.

# Progress, Purpose, & Participation PVA Southeastern Chapter



Southeastern Members,

The Chapter moves forward in a positive direction. The Chapter is no longer on monitoring status!! Now, at the Annual Convention and Fall Board of Directors meetings, Southeastern Chapter votes on National PVA resolutions which affect the organization's direction and members. With a new Chapter Executive Committee and Board of Directors, we are working hard to ensure the organization focuses on members' care, membership, sports, recreation, and legislation/advocacy.

We're not moving. The Board of Directors voted not to sell the Chapter headquarters on Deans Bridge Road in Hephzibah, Georgia. The headquarters requires a new roof and gutters. Through the grant writing service, grants will be researched and submitted to cover these costs.

To increase revenue, the Chapter office will organize an annual PVA Southeastern Chapter Golf tournament starting in 2026. Preliminary coordination has started with the Mount Vintage Golf Club located in North Augusta, South Carolina.

A member of the Chapter Finance Committee continues to conduct monthly Chapter reconciliation to ensure contributions are used efficiently. With these reconciliations, the Chapter is postured to complete an annual audit.

Informing locally elected officials at the federal and state level about access and disability legislation issues is imperative. # Veterans Responsibilities of Correct Mailing Address

Every veteran has certain responsibilities if he or she is in receipt of Service Connected or Nonservice connected benefits.

One of the first responsibilities is to report any change of address as soon as possible so that any sent VA correspondence is properly received by you. Address changes to the VARO can be reported by using the VA Form 20-572, REQUEST FOR CHANGE OF ADDRESS, or a VA Form 21-4138, STATEMENT IN SUPPORT OF CLAIM, by a direct letter from you to your local VARO, or by calling the VA 1-800 827-1000 number. Remember if you call in an address change you must back it up with written correspondence.

If you are service connected at 30 percent or greater and are receiving payments for any of your dependents such as your children, stepchildren and or a spouse you must notify the Veterans Administration Regional Office, VARO as soon as possible of any dependent changes. Such changes as to a child leaving your household, death of a dependent, divorce of spouse; are just a few that needs reported quickly, so as not to cause you as the veteran any possible overpayment.


Under compensation or Pension benefits, dependent changes such as your children or stepchildren attending school at age 18 through 23 are reported by using a VA Form 21-674, REQUEST FOR APPROVAL OF SCHOOL ATTENDANCE. This VA Form is sent to the veteran when the child is close to the age of 18. This VA form must be read completed and return to the VARO so that any adjustments can be made. This is one reason why your correct mailing address through the VA is important to keep updated. The VARO also every few years will verify your current listed dependents. This is done when the VARO will mail out a VA Form 21-0538, Mandatory Verification of Dependents. This VA form has to be reviewed, completed and returned within 60 days. If this form is not returned after 60 days, the VA could start to review your claim file for a possible overpayment action.

One item to remember is most VA mail is not allowed to be forwarded by a Post Office. If an address on the VA correspondence does not match. The correspondence is then to be returned by the Post Office to the VARO. Any return mail could cause your current VA benefits to be delayed until your mailing address is verified.
